January 21, 2020

The governing body of the City of Benton, Kansas met in regular session at the usual meeting place in the city at 7:00 p.m. Mayor Brennan Dennison presided. Members of the council were present as follows: Ross Schoneboom, , Mike Wyant, Curt Ghormley, Travis Swift and Janet Roths.

Pledge of Allegiance

Approve Minutes

Curt moved to approve the minutes from the December 16, 2019 regular meeting. Mike seconded. Motion carried 5-0.

Public Comment

Fire Board Appointment – Curt moved to recommend Tanner Swift and Chad Leep for appointment to the Butler County Fire Dist. #7 Fireboard. Ross seconded. Motion carried 5-0.

Executive Session

Janet moved to go into Executive Session at the request of city attorney Rob Lane to discuss non-elected personnel for 15 minutes at 7:05 p.m.

Reconvene

Travis moved to reconvene the meeting at 7:17 p.m. Curt seconded. Motion carried 5-0.

Other Business

Ross moved to donate \$400 to the Lions Club towards Benton Day t-shirts. Mike seconded. Motion carried 5-0.

Brennan informed the council he would be meeting with the manager of Stearman Bar & Grill to discuss ideas and events to benefit both the City and the Restaurant.

Brennan requested to be paid for 42 hours for time worked during the past two months. Curt moved to pay the mayor for 42 hours at \$25 per hour. Janet seconded. Motion carried 5-0.

Department Reports

Maintenance – Mark presented estimates for a building for equipment storage and demolition of the brown building on Main St.

Council would like to see estimates for mold removal in that building as well.

Presented an offer to purchase a Hydrovac from RWD #5 for \$18,000. A new one of the same size sells for \$25,000. RWD #5 is purchasing a larger one.

Curt moved to purchase the used Hydrovac from RWD #5 not to exceed \$18,000 to be paid from the Water Reserve Fund. Ross seconded. Motion carried 3-2.

Police – Braden informed the council of a new Part Time Officer, Kenneth Tamott,

The RMS system is down, we are unable to enter or pull information at this time. Discussed calls to service.

The new truck is here. We will be selling both crown vics on purple wave.

City Clerk – informed council the deadline to file with Butler County to run for office in the November 2020 election is June 1_{st}, 2020.

Pledge of Allegiance

Approve Minutes

Travis Swift moved to approve the minutes from the January 21, 2020 regular meeting. Curt Ghormley seconded. Motion carried 4-0.

Public Comment

Jake Myers, 435 S. Ohio St., spoke in favor of a new day care facility operated by Lacy Gould and the need for a facility that will be able to provide for a larger number of children.

New Business

Maria and Nick Engels presented an offer to purchase the property located on the NW corner of Main St and South St. (243 S. Main St.) for \$30,000.

After discussion Travis Swift moved to accept the offer of \$30,000 made by Nick and Maria Engels for the purchase of the 6 lots at 243 S. Main St. and they will be responsible for the removal of the brown building which sits on the property. Curt Ghormley seconded. Motion carried 3-0. Ross Schoneboom abstained.

Executive Session

Ross Schoneboom made a motion to recess into executive session to discuss non-elected personnel matters under Kansas Statute 75-4319(b)(1), at 7:20 p.m. for 15 minutes.

Motion was seconded by Janet Roths. Motion carried 4-0.

Reconvene

Travis Swift moved to return to open session at 7:35 p.m. Janet Roths seconded. Motion carried 4-0.

In view of the outcome of the independent investigation conducted by Butler County Sheriff's Office related to Mr. Hefton, and in light of the corroboration offered by the county attorney in filing charges related to a criminal act, I do not believe it to be possible for Mr. Hefton to remain an employee of the City of Benton. Therefore, I Curt Ghormley, move termination for Mr. Hefton effective immediately.

Motion was seconded by Travis Swift. Motion carried 4-0.

Other Business

Ross Schoneboom presented a proposal to increase council pay to \$200 per month and the mayor pay to \$500 per month effective at the beginning of the current incumbent seat expiration and reelection. Please consider the proposal and address the matter at the March council meeting.

Department Reports

Police - The new truck will be upfitted with equipment this week.

KBI Audit will be Wednesday

Will be adding police clerk to the court clerk position held by Kristin Beggs. This will allow compliance with the State for a TAC and LASO as well as maintaining better control and communication between the police office and court.

Maintenance – We will not be purchasing the Hydrovac from RWD #5 as they have decided to wait until next year to purchase a new one.

Signed the contract with TecNXS, an online backflow preventer registration and maintenance tracking program. This will keep us in compliance with KDHE. The cost is less than \$300 per year for their services.

Have inquired about a contract with Mayer Specialties for annual sewer line cleaning and to camera problem areas.

Street signs and signs at the Park have been installed.

Presented bids for buildings – council asked for estimates on garage doors, footings and installation costs.
